NB: These minutes are a record of what happened in the meeting, what was said, what was discussed, and what action would be taken where appropriate. Some items remain as ongoing from meeting to meeting so that they can be monitored at every meeting. Please be advised that no laptops will be allowed to be used in the Council Chamber and mobile phones will only be allowed to be used by the Police in emergencies.

Points from the Agenda:

1. Apologies for absence:

Jim welcomed the attendees to the NAG's Zoom meeting and reminded everyone it was being recorded. An Apology was received from William Luck.

2. Minutes from previous Zoom Meeting 19 October 2020:

The minutes were reviewed and accepted.

3. Matters arising:

Mike asked for an update regarding the robbery on Wokingham Road and Julie advised she would address this issue in the Police Update.

4. Update from the Neighbourhood Policing Team: Police Priorities

1. Road Safety & Speeding

Karen advised she had received an update from the Community Speedwatch Co-ordinator at the Joint Operations Unit (Speed Safety) Roads Policing confirming they are continually risk assessing the situation, but there is to be **NO COMMUNITY SPEED WATCH** activity until it is deemed that it is safe to do so.

2. Burglary

1 x Commercial – University of Reading

13 x reports of Criminal Damage – Silverdale Road, Rushey Way x 5, Finch Road, Langdale Gardens x 2, Wilderness Road, Allendale Road, Thyme Close, Lambourne Gardens

13 x Thefts from Vehicles - Mill Lane x 6, Maiden Place, Ramsbury Drive, Fleetham Gardens, Beech Lane, Aldbourne Avenue, Harcourt Drive and Sibley Park Road

1 x Theft of Motor Vehicle – Avalon Road

2 x Thefts of Pedal Cycle – Wokingham Road and Avalon Road

Julie advised she is concerned that reports of ASB have increased and read out a few received over the past month. Laurel Park has been affected, with the goal posts being pulled down and reports of 5-10 young people with 3 motorbikes smoking cannabis and playing loud music quite late at night. A similar report of youths was received for the Station Road car park. Collins Drive has ongoing ASB issues and the Neighbourhood Policing Team are looking at doing a problem-solving profile there. There have been reports of youths smoking cannabis in the Maiden Place youth shelter and groups of youths refusing to leave the local Sainsburys. There was only one report of eggs being thrown at a house on Halloween. The PCSOs have been going out and about in the area trying to engage with youths and dealing with Covid breaches. There is a dedicated police car working 24/7 responding to reports of Covid breaches. Jim reported that some of the staff at WH Smith in Maiden Place are not wearing

masks. Julie will ask the PCSOs to go and speak to them. Clive advised there was no Perspex barrier at the counter, and he would take this up with the Council. Jim mentioned the caretaker had put out a fire in the bins and there were masses of silver nitrous oxide canisters on Lower Earley Way plus little plastic bags have been appearing in the area. Jean advised there were lots of silver canisters at Maiden Place near the Church end and under the tree. Julie confirmed the team are keeping an eye on a group of youths who have been causing issues in the area. Jim mentioned that residents of Liberty House have reported groups of youths at the closed end of Cutbush Lane who may be receiving deliveries of drugs. Julie advised that reports of drug dealing have increased, Dave asked whether it was more blatant at the moment and Julie replied that she thought it was.

Simon advised the Priority Crime Team are investigating the reported robbery on Wednesday 11th November and are being assisted by the British Transport Police.

Mike asked if there had been an update on the Wokingham Road robbery and Julie advised that the aggrieved had described the offender as an Asian male, so his dashcam footage had been ruled out as it showed an elderly man in a grey tracksuit. She thanked Mike for his assistance.

Alan mentioned there had been reports of keyless entry cars being stolen. Julie advised that TVP have seen an increase and it has also been increasing nationwide. Simon advised they had not seen a large increase in this area as yet and it is important that people keep their keys secure and use a signal blocking pouch. Simon mentioned the following week is TVP's Burglary Intensification Week and there will be extra patrols and resources across the area.

Clive advised that vegetation in Swallows Meadow had recently been destroyed by the new land owner. The landowner has claimed that an environmental survey was carried out and did not even find a mouse in the area. However, local residents believe there may have been a badger sett in the area and Clive has asked the borough ecologist to visit the site to see if they can find evidence of it. If they find evidence, they will be coming to the police and asking them to act. Simon advised the Rural Crime Officer is part of his team and would deal with any issues that are found.

Jim advised the issues at Liberty House have reduced and are clearly under control. Liberty House are controlling the parking of visitors in Strand Way.

5. Maiden Place Youth Shelter

Jim advised some of the local residents have asked about getting rid of the shelter and wanted to know what the police thought of this. Julie advised they have spoken to ETC and WBC about this in the past. She believes the youth want to stay there and if there was no shelter, they would either congregate in the nearby flat stairwells or on the children's play area. The council are keen that there is a youth provision in the area and she believes there is a small minority of youths causing issues, not the majority of them.

6. Fly tipping and damage to cycle path fencing

Jim advised a barrier has recently been put around the damaged cycle path fencing and the fly tipping at the end of Lower Earley Way has been removed.

7. Laurel Park Football Club goal posts – damage

Jim asked Ian to provide an update on the goal posts. Ian advised they have not been able to identify those responsible. There was a group of 20-30 youths there on Halloween and at some point all of the goal posts were pulled down. No motorbikes or tyre tracks were reported on the field. They asked the council to keep the posts down during lockdown and they should be going back up at some point this week. The club put a message out asking for information, but nothing further has come through. Andrew asked that a note is put out after the meeting encouraging residents to report matters of concern to the police on 101. Jim advised he would get something put out on social media.

Any other business:

Alan advised that Santa's Sleigh will still be doing the rounds as they have now had relevant permission from the Local Borough Council, SAG and the Police but will not be stopping as their insurance will only allow a slow drive by. The routes will be published on Facebook and they are hoping to get donations online.

Ian advised they received some feedback regarding parking down Kilnsea Drive and confirmed the club is doing their best to encourage considerate parking on match days. Football was planned to resume and there should be 9 games. Improvements have been made to the pitches recently and hopefully a regular program will be implemented. Phil advised that some people are parking over dropped curbs on Marefield making it difficult for residents to manoeuvre in and out of their drives and asked if the club can put something out requesting people not to park over or right on the drop.

Dave thanked Julie for dealing with a recent racial incident and asked how it would be recorded. Julie advised it would be recorded as a racially aggravated public order because the victim perceived it as racist.

Jim asked Chris whether there was any update on the bins being emptied. Chris advised it had not been too bad lately and litter picking frequency has increased.

Mike mentioned that the size of the bin at The Three Tons entrance to Sol Joel should be increased. Jim suggested he email localities.environmental@wokingham.gov.uk and ask them to change the bin.

Prinal advised that university students who want to go home have a period between December 3rd to 9th to get tested.

Jim advised WBC have asked the NAG to send out Covid champion notices over the next 6 weeks. One notice is attached to the end of the minutes and one to the minutes email.

Andrew advised the lights on Chalfont Close are now working and he had received some lovely feedback from a resident who has been using the report it system. He also said there is a significant issue with overflowing bins in some parts of the area due to household rubbish being put into them. Someone has also been dumping big bags of rubbish next to the bins which the council is investigating. Andrew has asked MERA to put an appeal for people not to dump their household rubbish in their next newsletter. Alf advised an additional dog bin would be helpful in Dinton Pastures. Jim suggested contacting localities.environmental@wokingham.gov.uk. WBC advised that there is no funding at present for additional bins but would like to remind people that dog waste bags can be placed in normal council litter bins.

Helen asked whether there was any update on the gate. Clive advised he would ask for an update.

Phil asked if an update on the 20mph program could be provided at the next meeting.

The meeting closed at 8:31pm. Jim wished everyone a Happy Christmas.

Hi residents associations, community and neighbourhood groups,

We are writing to you about some of our latest Covid-19 data, which shows that cases are most prevalent in highly populated areas within the borough. This includes Wokingham town centre, Winnersh, Woodley, Earley, Shinfield and Twyford.

It is very important that we continue to encourage the right behaviours, follow social distancing advice, and adhere to the rules under Tier 2 (High) restrictions. This is crucial for keeping cases down and to avoid us moving to Tier 3 (Very High) on the next review date (16 December).

As such, we are asking those of you in the areas listed above to help us promote the following messaging:

Reduce our number of social interactions – the fewer people we meet, the less the virus spreads

- Wear a face covering where we are required to do so
- Wash our hands regularly with soap and warm water, especially before we leave home and when we return
- Make space from others, ideally two metres
- Self-isolate when we are asked to (please note, [support payments](#) are available to those who are eligible)
- Get tested if we have symptoms
- Keep our homes well ventilated, especially if someone within our household has tested positive or is showing symptoms

We understand it has been a tough and long year for many, but unfortunately the virus is still spreading across the borough and we cannot get complacent with these behaviours.
