Points from the Agenda:

1. Apologies for absence:

Acting Chair Phil Marsh welcomed the attendees to the meeting. Apologies were received from Simon Botham and Dan Bunting.

2. Minutes from previous Meeting (via Zoom) 22 November 2022:

The minutes were reviewed and approved in accordance with the matters arising in item 3.

3. Matters arising:

Jean advised the discussion point regarding the 3G pitch with the action for Jim Willis **to talk to Ian Jobson about any developments**, should have been included in the minutes.

Linden advised minutes from previous meetings were missing from the NAG's website.

Phil advised he would check into this.

Confirmation of new Chairman: Phil March was proposed, seconded and elected to the role by a unanimous vote. Phil mentioned he has applied for a grant from the PCC and if successful, would require the NAG to have a second signatory in the form of a Vice Chairman.

a) Road Safety & Speeding

There were no reported Thefts of Pedal Cycles.

Karen advised PCSO Dan Bunting has become part of the recent training intake for Police Officers and a new PCSO will be appointed for the area.

Police update compiled by Sgt Simon Botham: there have been a number of high value family jewellery burglaries in the area and our Priority Crime Team have ongoing investigations and are running a number of cross border operations with neighbouring Police forces in response.

Anti-social behaviour (ASB) issues persist in and around Maiden Place and the Police have identified a number of offenders and are working in conjunction with parents, schools and the Youth Justice Team. Last week was County Drug Lines week and there were a number of warrants executed which resulted in significant cash seizures.

With regards to the potential 3G pitch at Laurel Park, the Police have seen issues around ASB and youths attempting to access pitches at other locations. CCTV should be considered when planning an installation. Resourcing pressures are greater than ever before with Neighbourhood Officers being abstracted to core response.

5 WBC potential proposal for illuminated multi-purpose artificial grass pitch at Laurel Park / Maiden Erleigh School – any Policing concerns?

As mentioned above, consideration of CCTV is strongly recommended with any installation.

6 Current Traffic and Car Parking issues at Laurel Park on Weekends:

Pauline advised the possibility of an entrance off Rushey Way and a car park created by pushing the pitches back, is being evaluated. Residents of Marefield could consider a residents only parking scheme, but this would result in an administrative charge for parking permits. Andrew requested that the green space currently used for overflow parking and Jean requested that the area where basketball is played and the space behind the playground are not impacted by any changes. Andrew asked that the Highways team meet with both residents and the football club to discuss any potential issues prior to planning or consultations taking place. Andrew and Phil mentioned some potential minor improvements to the current car park had been suggested and passed to WBC. Andrew advised he would be happy to send a copy of the email sent to the council to Pauline. Phil suggested creating a working group on Zoom for all interested parties. Ian Jobson confirmed that approximately 200 vehicles cycled in the area on Saturday mornings

7 Orchard and Litter Picking:

Jean advised the orchard is having a monthly maintenance work party on the second Saturday of the month. A few fence posts have been pushed out of position, but most of the trees are thriving. The two trees that were missing for a couple of years have been replaced and all trees now have a label confirming their variety and a slate showing the sponsor's name. Jean and Andrew confirmed the litter pick is scheduled for Sunday 3rd April over two sessions: 10:00am-12:30pm and 2:00pm-4:30pm. McDonald's have pledged staff to support on the day.

8 Woodley & Earley Lions – Fireworks

Alan advised the Fireworks was a fantastic financial success with much larger numbers than in previous years. Advance-tickets accounted for half of the tickets sold. A debrief of the event is still to be held. The date for this year has been set for Saturday, November 5th. Following feedback from NAG members regarding issues they experienced with attendees at the event, Phil offered to speak to the Residents Association regarding assisting with marshalling. **Phil and Alan will look into the costs and possibility of silent fireworks.**

9 New Speedwatch process – Update

10 Street Parties – Queen's Platinum Jubilee

Residents can apply for a free street party license as long as it is not on a main road or bus route. The cut off date for applications is 15th May. The link for applications will be included with the minutes.

11 Any other business:

- a. Social media: it was suggested that the NAG post 1-2 items discussed during the meeting. Andrew suggested keeping your home secure and information regarding street parties. Possible sites are ERDB and We Love Earley.

- b. Linden advised there are issues around the area with potholes, lights and a manhole cover on Elm Lane. Pauline advised she will look into the issue with the manhole cover. **Linden to advise the manhole reference number to Pauline.**
- c. Phil mentioned the mini roundabout at the top of Carshalton needs repainting. Andrew encouraged everyone to use the council's Report It online system to make WBC aware of any issues.
